The District intends to impose assessments on benefited lands within the District in the manner set forth in the District's

Series 2017 Supplemental Assessment Methodology dated February 21, 2018 (the "Assessment Report"), which is on file and available during normal business hours at the address provided above. 

The assessments may be prepaid in whole at any time, or in some instances in part, or may be paid in not more than thirty (30) annual installments subsequent to the issuance of debt to finance the improvements. These annual assessments will be collected on the Manatee County tax roll by the Tax Collector. Alternatively, the District may choose to directly collect and enforce these assessments.
