Abundia Caycem will reactivate the grinding mill operations by performing overdue routine maintenance, repair, and replacement on the two existing finish mills and ancillary equipment used for material handling. The mills were permitted and operated by Argos to grind portland cement clinker, gypsum, limestone and other additives to produce finished cement of various types. Abundia Caycem will use the mills for the same purpose, but in addition, both of the existing finish mills will be modified to grind dried slag. Prior to grinding, the slag will be dried in a new natural gas fired dryer and transported to existing storage silos via a new bucket elevator and cross conveyor. Additionally, five of the existing baghouses, including the two baghouses serving the two finish mills, will be refurbished and fitted with membrane coated bags, and seven new baghouses, with membrane coated bags, will be installed. Based on potential to emit, proposed configuration and particular matter emissions controls, the facility will be classified as a minor non-Title V source
