Are there different types of legal notices?

Simply put, there are two basic types

Accountability notices are designed to make sure citizens know details about their government. These notices generally are published one time, and are archived for everyone to see. Accountability is key to efficiency in government.

No. While the internet is clearly a useful resource, websites should not be used as the sole source of a local potice.

Websites, whether controlled by a government body or a private firm, are not independent, archived, readily available or independently verified.

Newspaper legal notices fulfills all of those standards.


