The Department of Environmental Protection has granted an Environmental Resource Permit, number 0420235-002 EI, to John Swinford, c/o Hans Wilson & Associates, Inc., 1938 Hill Avenue, Fort Myers, FL 33901. The permit authorizes the following:
The permittee is authorized to install a dock with one uncovered boatlift and two mooring pilings to accommodate a 2nd mooring area for a new total over-water structure of 1,220 square feet in Pine Island Sound, Class II Outstanding Florida Waters, Conditionally Approved for shellfish harvesting, and part of Pine Island Sound Aquatic Preserve. Those activities include the use of 2,005 square feet of preemption of state-owned sovereignty submerged lands. 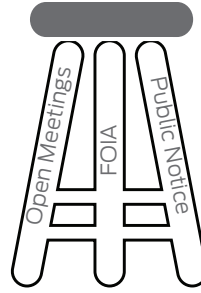

Along with open meeting and freedom of information laws, public notice is an essential element of the **three-legged stool of government transparency**



This is not about “newspapers vs the internet”.

It’s newspapers *and* newspaper websites vs government websites

and newspaper websites have a much larger audience. Moving notice from newspapers to government websites would **reduce the presence of public notices on the internet**



Requiring independent, third-party newspapers to ensure that public notices run in accordance with the law helps

prevent government officials from hiding information

they would prefer the public not to see

Since the first U.S. Congress, public officials have understood that newspapers are the best medium to notify the public about official matters because they contain the

essential elements of public notice:



Accessibility



Independence



Verifiability



Archivability

Publishing notices on the internet is neither cheap nor free



Newspapers remain the primary vehicle for public notice in all 50 states
