# Are internet-only legal notices sufficient?

# Are there different types of legal notices?

Accountability notices are designed to make sure citizens know details about their government. These notices generally are published one time, and are archived for everyone to see. Accountability is key to efficiency in government.

When the government is about to change your life, or your property or assets are about to be taken, public notices in newspapers serve to alert those affected

# How much do legal notices cost?

The price for notices in the printed newspaper must include all costs for publishing the ad in print, on the newspaper's website and to www. floridapublicnotices.com.
