We can't tell what's wrong from right!"

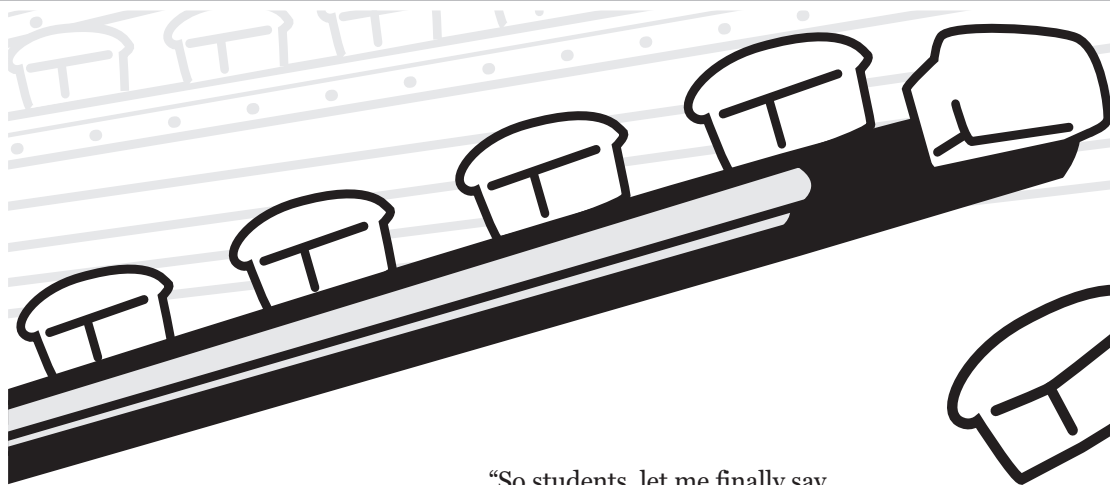
To comprehend confusion,

And then collapsed in tears!

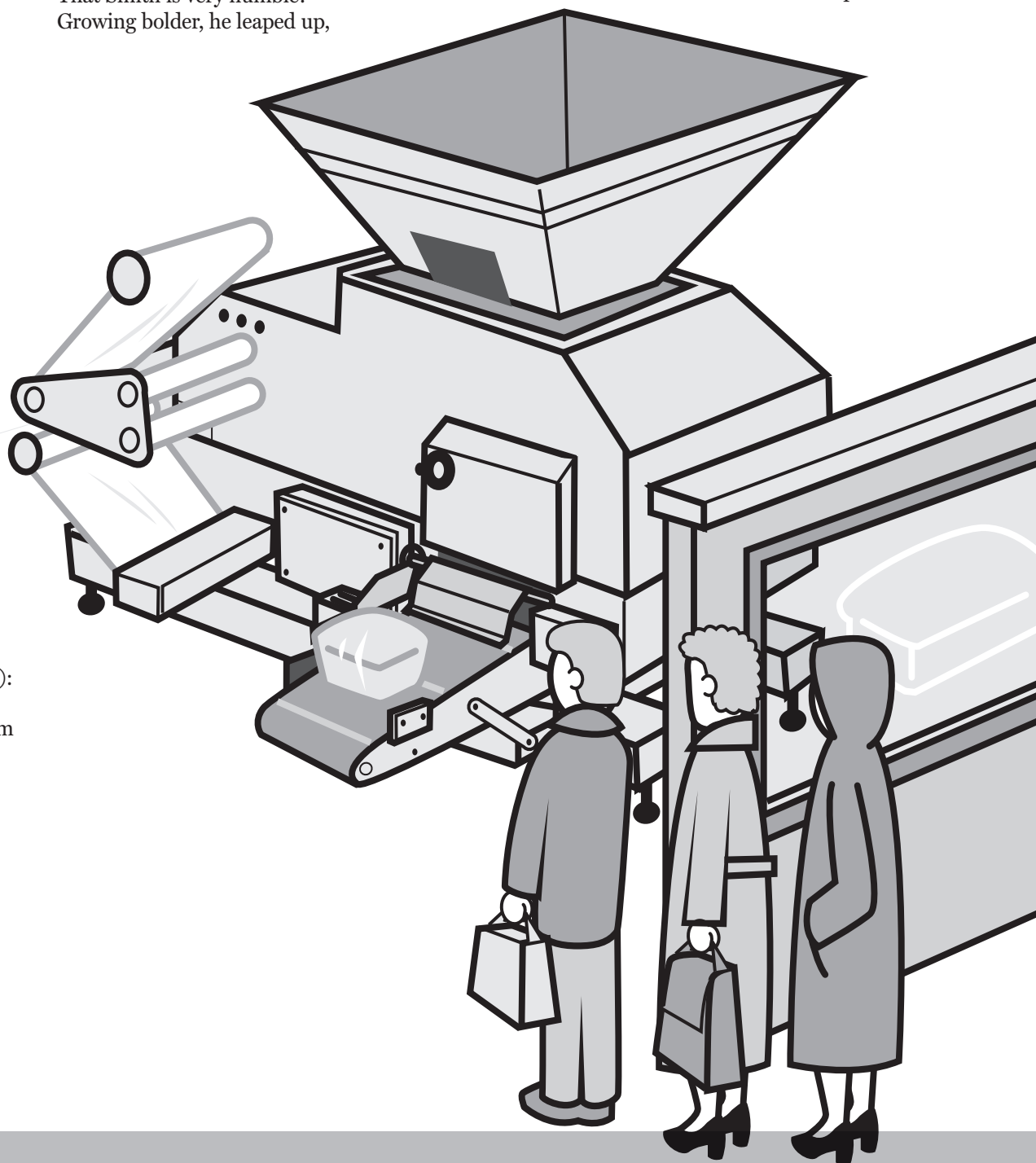
The clamor rises all about;
