

The streets and areas to be improved are geographically depicted below and in the District's First Amendment to Lakeside Preserve Community Development District Engineer's Report, dated August 2023, as may be further amended (the master project described therein, the **"CIP**". The public hearing is being conducted pursuant to Chapters 170, 190 and 197, Florida Statutes. The District is a unit of special-purpose local government responsible for providing infrastructure improvements for lands within the District. The infrastructure improvements expected to be funded by the District ("Improvements") are described in the CIP, and are currently expected to include, but are not limited to, roadways, stormwater management system, utilities (water, sewer, reclaim), hardscape/ landscape/irrigation, undergrounding of conduit, environmental conservation/ mitigation, amenities, off-site improvements, and other improvements, all as more specifically described in the CIP, on file and available during normal business hours at the District Manager's Office. According to the Phase 2 CIP, the estimated cost of the Improvements, including contingency and professional services, is \$11,450,000.

The District intends to impose assessments on benefited lands within the District in the manner set forth in the District's Amended and Restated Master Special Assessment Methodology for Lakeside Preserve Community Development District, dated September 2023, as may be amended and supplemented ("Assessment Report"), which is also on file and available during normal business hours at the District Manager's Office. The purpose of any such assessment is to secure the bonds

issued to fund the Improvements. As described in more detail in the Assessment Report, the District's assessments will be levied against all benefitted lands within the District. The Assessment Report identifies maximum assessment amounts for each land use category that is currently expected to be assessed. The method of allocating assessments for the Improvements to be funded by the District will initially be determined on an equal assessment per gross acre basis and will be allocated on an equivalent residential unit ("ERU") basis at the time that such property is platted or subject to a site plan. Please consult the Assessment Report for a more detailed explanation of the methodology.

The annual principal assessment levied against each parcel will be based on repayment over thirty (30) years of the total debt allocated to each parcel. The District expects to collect sufficient revenues to retire no more than \$17,550,000 in debt to be assessed by the District, exclusive of fees and costs of collection or enforcement, discounts for early payment and interest. The proposed annual schedule of assessments is as follows:

1. Assessments shall be levied to defray a portion of the cost of the Improvements as specified in the Amended Master Report.2. The nature and general location of, and plans and specifications for, the
