





According to the Engineer's Report, the estimated cost of the Improvements is \$23,760,000.

The District intends to impose assessments on benefited lands in the manner set forth in the District's Master Special Assessment Methodology Report, dated June 28, 2024 ("Assessment Report"), which is on file and available during normal business hours at the District Manager's Office.
