Flagler Beach Fishing Pier is located in a Special Flood Hazard Area (SFHA) Coastal High Hazard Area Zone VE. Confirmation of Flagler Beach Fishing Pier in the SFHA was determined by the Flagler County Flood Insurance Rate Map 12035C0232E and 12035C0251E, dated 06/06/2018. The proposed work conforms to all applicable State of Florida and local floodplain regulations. During the incident period, high winds, heavy rain, wave action, and storm surge damaged the Flagler Beach Fishing Pier, resulting in destruction of a 160 ft. long segment of pier and damages to the remainder of the pier.

Proposed Work and Purpose:

The reconstructed Flagler Beach Pier will incrementally increase to an elevation of 28 ft. NAVD88 at its furthest waterward extent, a change from its pre-disaster elevation of 17.8 ft. NAVD88. The new portion of the pier will be reconstructed of concrete with breakaway timber decking and widened by 5 ft. per codes and standards. 
