The applicant, MSKP Town and Country Utility, LLC, William R. Vander May, Vice President, 4500 PGA Boulevard, Suite 400, Palm Beach Gardens, Florida 33418 applied on September 24, 2024, for a construct and operationally test permit for a Class I injection well system. The project is located at MSKP Town and Country Utility Water Treatment Plant, 12150 State Road 31, Punta Gorda, Florida 33982, in Charlotte County (File 0294077-002-UC/1I, WACS ID 99130).

The permittee will construct and operationally test one non-hazardous Class I injection well, IW-1, and associated dual-zone monitor well DZMW-1 for the disposal of reverse osmosis wastewater from the Town and Country Water Treatment Plant and domestic wastewater treated to high-level disinfection standards from a future wastewater treatment facility. The maximum injection rate for IW-1 shall be 5,132 gallons per minute and the maximum injection volume for IW-1 shall be 7.39 million gallons per day. The injection well is constructed with a 24-inch diameter steel casing set to 2,650 feet below land surface (bls), a 16-inch diameter fiberglass-reinforced plastic tubing set to 2,650 feet bls with a cemented annulus, and total depth of 3,600 feet bls. The dual-zone monitor well DZMW-1 will be completed in the Ocala Limestone from 1,050 to 1,100 feet bls and Avon Park Formation from 1,700 to 1,750 feet bls in the Upper Floridan Aquifer.

The Department has permitting jurisdiction under Chapter 403 of the Florida Statutes (E.S.) and the rules adopted thereunder. The project is not exempt from permitting procedures. The Department has determined that an Underground Injection Control permit is required for the proposed work.

The Department will issue the permit unless a petition for an administrative hearing is timely filed under Sections 120.569 and 120.57, F.S., before the deadline for filing a petition. On the filing of a timely and sufficient petition, this action will not be final and effective until further order of the Department. Because the administrative hearing process is designed to formulate final agency action, the hearing process may result in a modification of the agency action or even denial of the application.

Every citizen in the jurisdiction affected by the notice must have a realistic opportunity to read it



2. Archivable

Notices must be capable of being archived in a secure and publicly available format for the use of the judicial system, researchers and historians



202 3. Independent

Notices must be published by organizations independent of the government body or corporation whose plans or actions are the subject of the notice



4. Verifiable

There must be a way to verify that each notice was an original, unaltered notice and actually published in accordance with the law
